In the direct representation program, TDS represents people imprisoned in Texas because of extreme punishments, from the death penalty to life sentences for third-degree felonies, and advocates for people seeking a second chance through the parole system. TDS fights for our client's right to a second chance, focusing on cases that highlight how excessive punishments fuel mass incarceration, perpetrate injustice, and fail to serve public safety. Through the policy reform program, TDS advocates for local and state-wide reforms that will end excessive punishment and shrink mass incarceration in the Lone Star State.
